REPORT SUBJECT UNDER CONSIDERATION:

The Letter from Peter Gaz LLC №5253 of 08.10.2013 (entry from 10.10.13 №78-7479/13-0) on the possibility of economic development of a plot of land of 57.72 ha for the placement of landfall facilities of the South Stream Offshore Pipeline section in the area of the town of Anapa. Section South Stream Offshore Pipeline (Russian sector). Project documentation. Section 10. Other documentation in cases provided for by federal laws. Part 5. Measures for the conservation of cultural heritage. Book 2. Onshore section (16/13/2013-П-СОКН1.2), completed by Peter Gaz LLC in 2013.

SUMMARY:

The plot of land of 57.72 ha is located on the territory of the town of Anapa, Krasnodar Krai.

INFORMATION ON HISTORICAL AND CULTURAL MONUMENTS:

According to information from the unified register of cultural heritage, the list of identified cultural heritage items of the town of Anapa, the section South Stream Offshore Pipeline (Russian sector). Project documentation. Section 10. Other documentation in cases provided for by federal laws. Part 5. Measures for the conservation of cultural heritage. Book 2. Onshore section (16/13/2013-П-СОКН1.2), completed by Peter Gaz LLC in 2013, the considered plot of land is partially located within the boundaries of the archaeological protective zone of the Burial Mound (gos. №363) (height 2.97 m; diameter 29 m), Varvarovka, 1.5 km along the Shingar river. The monument is under state control by decision of the executive committee of Krasnodar Krai Council of People's Deputies of 29.01.1975 № 63.

In accordance with article 17 of the Law of Krasnodar Krai "On lands of immovable cultural heritage (monuments of history and culture) of regional and local importance located on the territory of Krasnodar Krai and their protection zones" of 19.07.2011 № 2316-KZ for the protection of items of cultural heritage - burial mounds up to 3 metres high - 125 metres from the border of the monument around its whole perimeter.

REQUIREMENTS:

In connection with the partial location of the site within the archaeological protection zones in accordance with paragraph 4, article 26 of the Law of Krasnodar Krai of 6th February 2003 № 558-KZ "On cultural heritage (monuments of history and culture) of the peoples Russian Federation located on the territory of Krasnodar Krai" and restoration rules (SRP-2007, 4th edition), it is necessary:

- that all types of excavation and construction work on the land within the boundaries of the monument protection zones are conducted under the supervision of a specialist archaeologist;
- to inform the state body for the protection of monuments of the beginning of excavation work within the boundaries of the archaeological protection zones in writing no later than 3 days prior to the start of work (tel. fax 268-32-23);
- if archaeological items are identified during professional archaeological supervision, work will be suspended until the issue of saving the item of archaeological heritage has been resolved (article 35 and 37 of the Federal Law of 25.06.2002 № 73-FZ); and
- all above mentioned work shall be conducted at the Customer's expense.

CONCLUSIONS:

The Department for State Protection of the Cultural Heritage of Krasnodar Krai approves the economic development of the plot of land of 57.72 ha for the placement of planned facilities on the landfall section in the area of the town of Anapa for the South Stream Offshore Pipeline section located on the territory, in accordance with presented documentation and on condition that the requirements listed above are complied with.
